MICROCHIPPING AND REGISTRATION

An owner is no longer be entitled to a reduced fee for their animal being microchipped alone. To be entitled to a reduced fee the animal must be microchipped and meet 1 or more of the categories below:

- Over 10 years of age, or
- Undergone Accredited Obedience Training, (Not puppy school)
- Part of a Domestic Animal Business (DAB)
- or Applicable Organisation. Proof is required.

STATE GOVERNMENT LEVY

The above fees include the State Government Levy. The State Government Levy of \$4.10 for dog registration and \$4.10 for cat registration is primarily used to fund responsible pet ownership educational programs.

COMPULSORY DESEXING OF CATS

If you own a cat in Stonnington it must be de-sexed. Council will not register a cat unless it is desexed. **Exemptions** will only be made for cats for **registered** breeding purposes or due to veterinary advice. Desexing your cat will help reduce the number of stray and unwanted cats in Stonnington.

COMPULSORY MICROCHIPPING

Council will not register a dog or cat that has not been implanted with a microchip. This includes previously registered dogs and cats that move into the City of Stonnington from another Council. Proof of Microchipping must be supplied ie: microchip certificate or veterinary report.

EXTRA ANIMAL

To keep more than 2 dogs and 2 cats, you will require an excess animal permit. Apply online or contact Council on **8290 1333**.

CONCESSION

If you wish to claim a concession you must supply proof of your current Commonwealth Pensioner Concession Card or Department of Veteran Affairs Pensioner Concession Card.

RESTRICTED BREED

The *Domestic Animals Act 1994* requires the following restricted breeds to be declared: Pitbull Terrier, American Pitbull, Terrier, Japanese Tosa, Fila Brasileiro, Dogo Argentino and Perro de Presa Canario (Presa Canario).

PURCHASED FROM A NOT-FOR-PROFIT ORGANISATION

If you provide proof of purchase from a not-for-profit animal welfare organisation you will receive subsidised registration fees. Initial registration will be charged at \$5.00. Full year registration fees will be applicable for the following animal registration period commencing 10 April 2020.
