# **APPLICATION TO AMEND A PLANNING PERMIT**



### **Amending a Planning Permit**

#### **Section 72 or Secondary Consent?**

A Section 72 Amendment is an amendment that is made under the Planning and Environment Act 1987. Section 72 Amendments are required when a change requires what the permit allows or permit conditions to be amended, there is potential material detriment as a result of proposed changes.

Secondary Consent amendments can only be used to make small changes to endorsed plans. Changes can only be considered under Secondary Consent if they don't result in a transformation of the proposal, don't require primary consent under the scheme, is of no consequence under the relevant planning controls and is not contrary to a specific requirement of the permit.

# Lodging your application to amend a planning permit

Applications made under Section 72 of the *Planning and Environment Act 1987* must include the information required by Regulation 14 of the *Planning and Environment Regulations 2015*.

When submitting an amendment application ensure that all plans are of the same scale and type as those that have been approved. Ensure that all amendments are clearly highlighted on any new plans submitted, as failure to do so is likely to result in delays. Highlight changes by using different colours, highlighter pens or bubbles around amendments, etc
